



Volunteer Release and Waiver of Liability

This release and Waiver of Liability (the "Release") executed on this _____ day of _____, by _____ (the "Participant") in favor of GIVING THE A.S.S.I.S.T., A MISSOURI CORPORATION, a non-profit corporation organized and existing under the laws of the State of Missouri, USA, its directors, officers, employees, volunteers and agents (collectively, "GIVING THE A.S.S.I.S.T.").

I, the Participant, desire to volunteer with GIVING THE A.S.S.I.S.T. to provide emergency disaster relief or other services and engage in the activities related to offering these services or for any other reason. I understand that the activities may include, but are not limited to, travel to disaster or other sites in the United States and throughout the world; transportation in private, commercial and GIVING THE A.S.S.I.S.T.-owned vehicles; moving and lifting heavy objects; cooking and serving food; towing and recovering vehicles and working and inhabiting environments that may be without power, sanitation, or are otherwise damaged by a disaster or other event.

I hereby freely and voluntarily, without duress, execute the Release under the following terms:

1. Waiver and Release. I, the Participant, release and forever discharge and hold harmless GIVING THE A.S.S.I.S.T. from any claim or liability that I, the Participant, may have against GIVING THE A.S.S.I.S.T. with respect to any bodily injury, personal injury, illness, death or property damage that may result from my participation in a disaster relief or other operation. I also understand that GIVING THE A.S.S.I.S.T. does not assume any responsibility or obligation to provide financial or other assistance, including, but not limited to medical, health, or disability insurance, in the event of injury, illness, death or property damage.

2. Insurance. GIVING THE A.S.S.I.S.T. does not carry or maintain, and expressly disclaims responsibility for providing any health, medical or disability insurance coverage for the Participant. EACH PARTICIPANT IS ENCOURAGED TO CARRY PERSONAL LIABILITY OR HEALTH INSURANCE PRIOR TO REGISTERING AS A GIVING THE A.S.S.I.S.T. WORKER.

3. Medical Treatment. Except as otherwise agreed to by GIVING THE A.S.S.I.S.T. in writing, I hereby release and forever discharge GIVING THE A.S.S.I.S.T. from any claim whatsoever which arises or may hereafter arise on account of any first-aid treatment or other medical services rendered in connection with an emergency during my time with GIVING THE A.S.S.I.S.T..

4. Assumption of Risk. I understand that my time with GIVING THE A.S.S.I.S.T. may include activities that may be hazardous to me, including, but not limited to, cook and food preparation activities, loading and unloading of heavy equipment and materials, transportation to and from the disaster or other site, and working in locations damaged by the effects of a disaster or is otherwise hazardous. I recognize and understand that my time with GIVING THE A.S.S.I.S.T. may, in some situations, involve inherently dangerous activities. I hereby expressly and specifically assume the risk of injury or harm in these activities and release GIVING THE A.S.S.I.S.T. from all liability for injury, illness, death or property damage resulting from the activities of my time with GIVING THE A.S.S.I.S.T..

5. Photographic Release. I grant and convey unto GIVING THE A.S.S.I.S.T. all right, title and interest in any and all photographic images and video or audio recordings made by GIVING THE A.S.S.I.S.T. during my work for GIVING THE A.S.S.I.S.T., including, but not limited to, any royalties, proceeds or other benefits derived from such photographs or recordings.

6. Other. I understand that it is my desire to further the work of GIVING THE A.S.S.I.S.T. by performing services as a Volunteer, specifically as an A.S.S.I.S.T. Volunteer. I undertake to perform said services as a Volunteer without compensation and that, in performing said services, I acknowledge that I am not acting as an employee of GIVING THE A.S.S.I.S.T..
